- b) **St. Charles Parish Occupational License:** Contact St. Charles Parish Sheriff's Dept. at 985.783.6237 for license and questions on permit fees. Renewed annually.
- c) **St. Charles Parish Home Occupational License:** (for St. Charles residents), Contact St. Charles Parish Planning & Zoning Department (985.783.5060) Fee \$25 No renewal required.
- d) **Health & Hospitals Office of Public Health Permit:** (for vendors who deal with protein food items or vendors who are not under Cottage Law )
- e) **Food Safety Class Certificate:** (for vendors who deal with food)
